I/We hereby confirm my/our understanding and acceptance of the below terms and conditions: 本人/吾等確認明白及接納下述條款及細則:

- The monthly subscription fee of an RTQ subscription is calculated on a monthly basis, from the first working day of the month or the effective date until the end of that month. In case of termination before the end of a month, the monthly subscription fee will not be refunded. The payment will be deducted from your securities / futures trading account on the day of approval for the first month, and subsequently deducted at the end of each month in advance for the subsequent months.
